CHAIRMAN'S MESSAGE

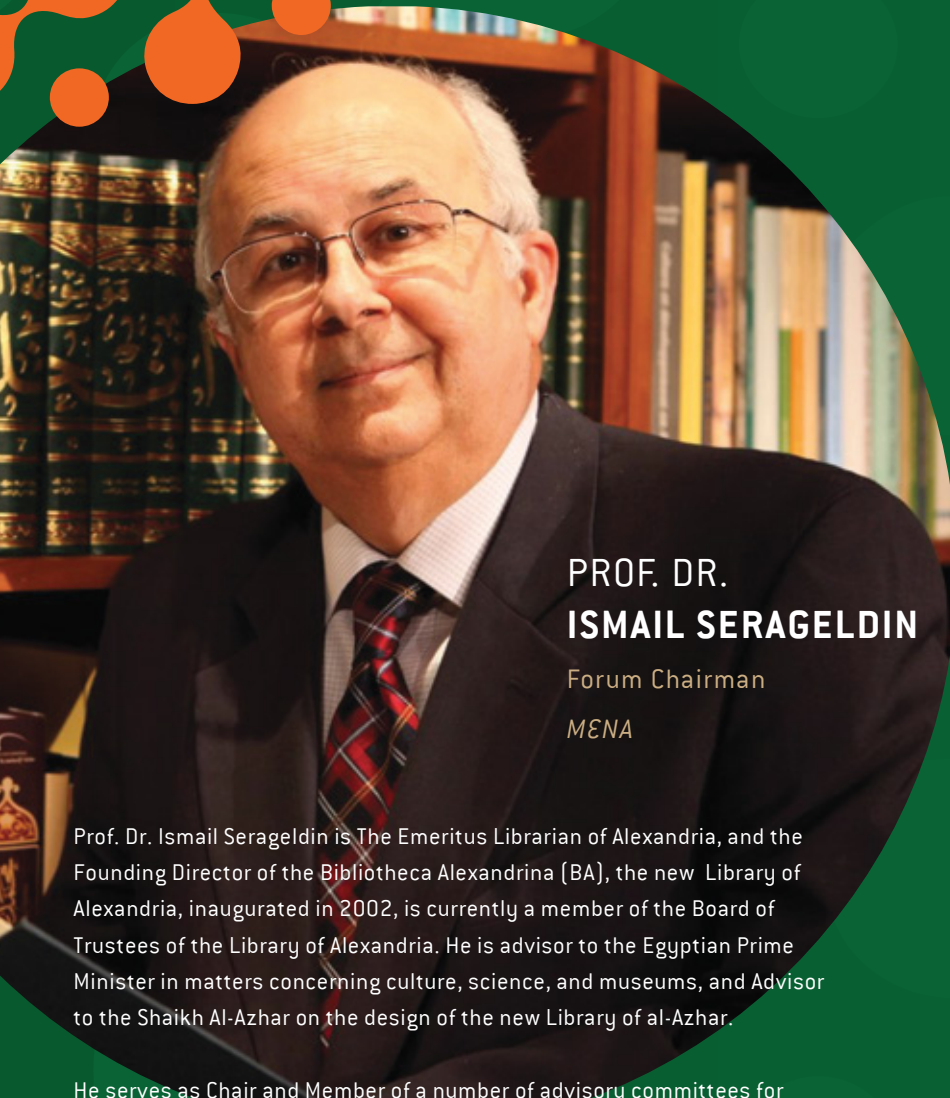

Prof. Dr. Ismail Serageldin is The Emeritus Librarian of Alexandria, and the Founding Director of the Bibliotheca Alexandrina (BA), the new Library of Alexandria, inaugurated in 2002, is currently a member of the Board of Trustees of the Library of Alexandria. He is advisor to the Egyptian Prime Minister in matters concerning culture, science, and museums, and Advisor to the Shaikh Al-Azhar on the design of the new Library of al-Azhar.

He serves as Chair and Member of a number of advisory committees for academic, research, scientific and international institutions, including as co-Chair of the Nizami Ganjavi International Center (NGIC), and serves on the Board of the Science and Technology for Society (STS) Forum in Japan, and is a member of the Science Advisory Council (SAC) of the Islamic Development Bank and the SAC of the World Food Prize, and the SAC of the African Open Science Platform (ADSP), and also serves on the Steering Committee of the Innovation for a Cool Earth Forum (ICEF) in Tokyo.

He held many international positions including Vice President of the World Bank (1993-2000). He also co-chaired the African Union's high level panel for Biotechnology (2006) and again for Science, Technology and Innovation (STI) in 2012-2013, and was a member of the ICANN Panel for the review of the internet future (2013). He was inter-alia the Chairman (1994-2000) of the Consultative Group for International Agricultural Research (CGIAR) and the co-chair of the Inter-Academy Panel on Capacity Building for Science Research (2002-2004). He has served on the Advisory Committee of the World Social Science Report for 2013 and 2016, and Chaired the Executive Council of the World Digital Library (2010-2017). More recently he was a member of the National Academies' panel on Human Genome Editing (2017).

Dr. Serageldin has received many awards including: The Order of the Rising Sun -- Gold and Silver Star awarded by the Emperor of Japan (2008); Knight of the French Legion of Honor awarded by the President of France (2008); The Public Welfare Medal, by the National Academy of Sciences, Washington DC (2011); and is a Commander of the Order of Arts & Letters of France (2011); and holds the Nizami Ganjavi Gold Medal of the Republic of Azerbaijan, as well as many other awards.

He has lectured widely all over the world including delivering the Mandela Lecture (Johannesburg, 2011), the Nexus Lecture (Netherlands, 2011), the Keynote Address to the First International Summit of the Book (Washington DC, 2015), and the initiating lecture of the series "Out of the Ashes" at Trinity College Dublin (2018). He was distinguished professor at Wageningen University and at the College de France. He has published over 100 books and monographs and over 500 papers on a variety of topics. He holds a Bachelor of Science degree in engineering from Cairo University and a Master's degree and a PhD from Harvard University and has received over 35 honorary doctorate.

SIR TIM HUNT, FRS

Biochemist, Nobel Laureate in Physiology or Medicine, 2001
United Kingdom

Tim Hunt was born in 1943 at Neston, near Liverpool, but grew up in Oxford, where he became fascinated by science at the Dragon School. At 14, he entered Magdalen College School, where his interest in biology grew. Tim entered Clare College, Cambridge in 1961 to read Natural Sciences. He joined the Department of Biochemistry in 1964 as a graduate student working on the control of haemoglobin synthesis. In 1968 he moved to the Albert Einstein College of Medicine in New York as a postdoctoral Fellow with Irving London.

Tim returned to Cambridge in 1971 and continued to work on translational control throughout the 1970s. He taught summer courses at the Marine Biological Laboratory, Woods Hole, Massachusetts from 1977 to 1983, looking at changes in protein synthesis in sea urchin and clam eggs after fertilisation. In 1979, he helped Joan Ruderman and Eric Rosenthal with experiments on the translational control of maternal mRNA in clam eggs, where two of the major mRNAs concerned later turned out to be the A and B-type cyclins. By 1982, Tim had almost exhausted the potential of sea urchin eggs, but it was then that he performed the experiment that led to the discovery of cyclins and subsequent research on the control of the cell cycle. In 1990, Hunt joined ICRF (now The Francis Crick Institute) in London. He became a fellow of the Royal Society in 1991, a foreign associate of the US National Academy of Sciences in 1999 and shared the 2001 Nobel Prize for Physiology or Medicine. He enjoys cooking and making up problems for Molecular Biology of the Cell with his friend John Wilson. In 2016, he and his wife Mary Collins moved from London to Okinawa, where Mary is the Provost of OIST (Okinawa Institute of Science and Technology).

Mr. Bambang is the current Minister of Research and Technology & Chairman of the National Agency for Research and Innovation of the Republic of Indonesia, conducting affairs in the field of research, science and technology to assist the President of Indonesia. He has previously held Ministerial positions in Indonesia's Working Cabinet, most notably taking up the role as the Minister of National Development Planning from 2016 to 2019 and the Minister of Finance from 2014 to 2016.

Mr. Bambang has also seen endeavours outside of the Indonesian Government, taking up the role as Director General of the Islamic Research and Training Institute (IRTI), a member of Islamic Development Bank in Jeddah, Saudi Arabia from 2009 to 2010. Prior to that he served senior positions with University of Indonesia, most notably, serving as the Dean of the Faculty of Economics from 2005 to 2009 and Chairing the Department of Economics from 2002 to 2005.

Mr. Bambang currently serves at the Directorial level of various organizations serving as Chairman of the Board of Director at ASEAN Infrastructure since 2013. Additionally, he was the Alternate Governor for Indonesia to the International Monetary Fund (IMF) since 2014 and is also the National Coordinator to the Organization for Economic Cooperation and Development (OECD) since 2012.

Mr. Bambang holds a Bachelor of Economics from the University of Indonesia; a Master of Urban Planning and a Ph.D. in Urban and Regional Planning, both from the University of Illinois.

He held numerous positions at the International Islamic University Malaysia (IIUM), including Deputy Rector [Academic & Research], Dean of Institute of Islamic Banking and Finance (IIBF) and Dean of Faculty of Economics and Management Sciences. Dr. Azmi holds a BSc (Finance) and MBA from Northern Illinois University, the United States of America and a PhD in Finance from Bangor University, Wales, United Kingdom. He is also a holder of Chartered Professional in Islamic Finance. He serves as a member of the Shariah Committee to Bank Rakyat Malaysia and Etiqa Takaful Malaysia and an Islamic Finance Expert to the Autoriti Monetari Brunei Darussalam. Recently he led a team that developed the Indonesia Shari'ah (Islamic) Economy Masterplan 2019-2024 for the government of Indonesia.

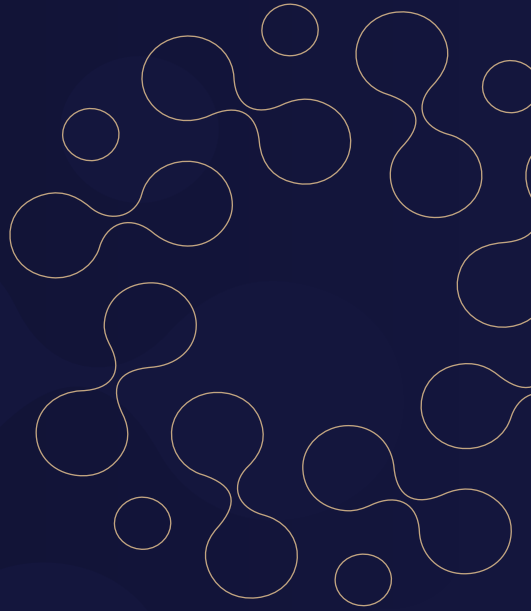

Environmental problems from Climate Change to local pollution and the management of solid waste require the urgent deployment of appropriate solutions with the engagement of the local populations. But the proposed policies and projects must be based on sound scientific analysis. Countries need science-based policies and evidence-based regulations. On the existential issue of Climate change, we need to curb emissions as well as to promote resilience through adaptation. Neither alone will work. Under current programs, it is extremely unlikely that we can reach zero net emissions by 2050, and hence it seems that the world will converge towards a future where global warming will likely be at around 4 to 5 degrees rather than the desired 1.5 to 2.0 degrees discussed at the Paris accord. Limiting the emissions through renewable energies or reducing them through carbon capture, sequestration and re-use must accelerate drastically. This involves the soils, the seas and the forests, and affects the policies dealing with agriculture and deforestation. So, what can we say about this?

Islamic social finance tools have been instrumental in the alleviation of poverty and socio-economic development for over 1,400 years. Some of these instruments have been adopted and applied even outside the Islamic world. One instrument in particular – Waqf (endowment) – has been utilized even at the establishment of the Oxford University's Merton College in 1264. Throughout Islamic history, Waqf was the main provider for many of the social services that today are financed by the state. These include the provisions of education and healthcare, infrastructure development and maintenance as well as social welfare provisions for the poor and destitute. Waqf institutions have also supported a more equitable distribution of income and wealth as wealthy individuals and families released property into the service of the people for 'doing good'. Although a significant number of Waqf institutions exist globally, the success of these institutions relies on efficient governance, regulation, supervision mechanisms and effective management. Since most countries and regions do not have enabling Waqf regulations or monitoring processes, the value and output of Waqf assets are mostly on the decline. The potential, however, is enormous.

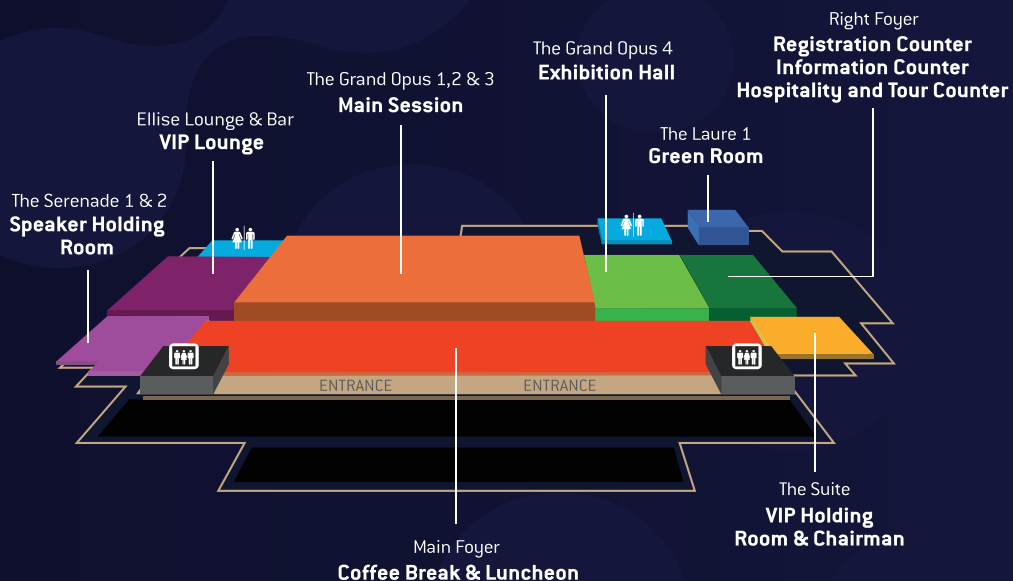

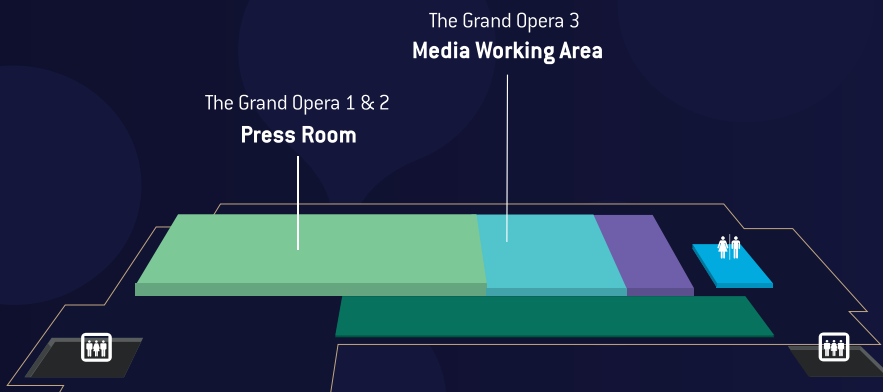

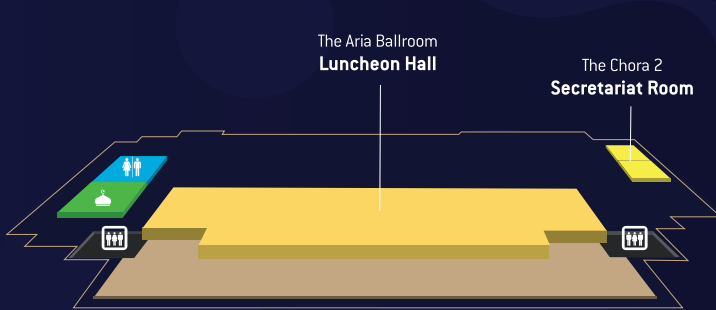
